

CCP RECLAMATION FACTS:

- > CCPs are solid waste when abandoned or accumulated or stored before being disposed of.
- > CCPs are not solid waste when legitimately reclaimed.
- > CCPs that are not a solid waste are not a hazardous waste.
- > Shipments do not require a hazardous waste manifest.
- > DOT shipping requirements apply.
- > Records of shipments must be maintained by generators.
- > CCPs must be appropriately stored and managed as a valued commodity.
- > CCPs are profiled on a TRADEBE Product Profile.
- > TRADEBE's Product Approval Letter will be provided after product assessment and product reclamation verification has been completed.
